## 1) Follow up on Action Points from 24th January 2018

The minutes from the 24th January 2018 were approved

2) Update on Visioning Events/Workshops and Engagement/Plan Making Strategy dates and itinerary and follow on from Agenda item 4 from Steering Group meeting 24<sup>th</sup> January 2018:

2018 first quarter action plan: 1) **Engagement / Vision**; AECOM technical support / Next phase / How best to use AECOM. 2) **Planning**; HOUSING - SITE18 – KIBA - HIGH STREET - SOCIAL INFRASTRUCTURE - TRANSPORT AND COMMUNICATIONS - ENVIRONMENT - QUALITY AND DESIGN

Tom has devised a strong methodology for the #Our Kind of Norwood (#OKN) framework and action plan. Tom's #OKN document offers a step-by-step guide including a table of contents and timeline. This can be used to give leverage when talking to BID (S2S) or Lambeth Council.

Graham expressed his concern about the lack of resource to get The Plan completed in realistic time although The Plan doesn't have to be comprehensive.

### **Action**

- Graham/Tom to invite Ben Castell from Dartmouth Park Neighbourhood Forum to talk at an NPA steering group meeting.
- AECOM's Design Code offers 2 Visioning event meetings (will include NPA's agm) plus 2 smaller meetings about Site 18 and KIBA. Amanda will liaise and engage with appropriate personnel to book venues and organise all meetings.
- Time events during Campaign season
- Draft a set of policies (Who?)
- This phase to be completed by October 2018
- NPA needs a VISION STATEMENT
- Tap into groups such as Greening West Norwood, Norwood Collective

- First Visioning event + agm agreed for 25<sup>th</sup> April 2018 and second 18<sup>th</sup> May
- Flyer for event #1 to be ready before Easter
- Tom ? to approach Fred Cowell/BID to jointly host meeting on 18<sup>th</sup> May
- Third meeting VISIONING Event #2 at Chatsworth Baptist Hall and/or possibly a Feast event
